2017 Revelstoke Early Childhood Development Photo Contest

Official Rules

The following Contest ("Contest") is intended for participants living in Revelstoke, British Columbia only. To enter and to be eligible to win, entrant must be a resident of Revelstoke, British Columbia and be nineteen (19) years of age or older. By participating, you agree to abide by and be bound by these Official Rules.

HOW TO ENTER: The Contest starts at 8:00 am Pacific Time on May 16, 2017 and closes on June 2, 2017 at 5:00 pm Pacific Time ("Contest Period"). During the Contest Period participants may enter by visiting the Revelstoke Early Childhood Development (Sponsor") website located at www.revelstokeearlychilddevelopment.com and clicking on the Photo Contest link. Participant must complete an entry form and photo consent form. Participants then upload up to a limit of five (5) photos that adheres to the photo submission guidelines which will be entered into the Contest ("Entry"). The Sponsor will not willfully disclose individually identifiable information about a contestant to any third party without first receiving the contestant's permission. The Sponsor will not share or sell a contestant's personal information to other companies, organizations or individuals. Any inquiry concerning the personal information held by the Sponsor should be addressed to Revelstoke Early Childhood Development Committee, Box 2059, Revelstoke, BC, V0E 2S0. Once submitted, entries cannot be deleted, cancelled, or modified. The entrant is responsible for all costs associated with uploading a photo. In the event that more than one of exactly the same photo is submitted, only the first submission received shall be accepted. All entries must be received by 5:00 pm (PST) on June 2, 2017. Facebook 'likes' will be accepted until 5:00 pm (PST) on June 5, 2017. Incomplete entries, or those containing incorrect information, will be voided. Proof of sending or submission will not be deemed to be proof of receipt by Sponsor.

PHOTO SUBMISSION GUIDELINES: All photos must show at least one child under 6 years of age and/or pregnant mom(s). Photo resolution should be a minimum of 300dpi, or the highest resolution setting on your camera. File size must be a minimum of 1.5MB but cannot be more than 32MB. Photo must be in jpeg format and must not contain objectionable content. Photos must not contain, depict any sexually explicit, disparaging, discriminatory, offensive, illegal or otherwise unsuitable content (as determined by the Sponsor, at its sole discretion). Photos must be reflective of the ""Kinds of Photo We Are Looking For"" as described in the Photo Contest information located on our website. By submitting a photo to this Contest you represent and warrant that you are the original creator of the photo; that you are the sole owner of the photo and any copyright on the photo; that you can provide written consent and a release from any person that is featured in the photo. All Contest entrants must be able to produce written consent (Photo Release Form) from the parents or guardians of any person appearing in the submitted photo if that participant is under the age of majority in the Province of British Columbia. Photo Theme: *Learning Something New*.

PRIZES: There is one (1) Grand Prize consisting of one (1) Basic Family Photo Session provided by Sarah Mickel Photography. Odds of winning will depend on the number of entries received. Finalists will be determined by the Sponsor based on the photo submission guidelines as described above. Photos will be posted onto the Revelstoke Early Childhood Development Facebook page on a weekly basis. There will be 10 finalists that will be selected by the photos with the most facebook "Likes" as determined by facebook users. The grand prize will be awarded to the finalist that the Sponsor deems as having most closely matched to the judging criteria. The Grand Prize Winner will be announced on June 8, 2017. Winning entrants will be contacted by telephone within 48 hours after the Contest Award Date. The Grand Prize is non-transferable and must be accepted as awarded without cash substitutions. Prizes will be forfeited if not redeemed in accordance with these Rules. If the Prize is unavailable for any reason, the Sponsor reserves the right to substitute the Prize or any component thereof, with items of equal or greater value. Failure to collect a prize within thirty (30) days of notification of award constitutes forfeiture of the prize.
